



Digital Device usage/Internet/Social Media Policy

Internet Use Policy

1. Purpose

This Internet Use Policy outlines the expectations, responsibilities, and guidelines for the appropriate and safe use of the internet and digital resources at Disha Indian International School. The policy aims to support educational excellence while fostering a secure and respectful online environment for all members of the school community.

2. Scope

This policy applies to:

- All students, teachers, staff, and visitors using the school's internet network or devices.
- School-owned devices used off-campus.
- Personal devices connected to the school's network.

3. Acceptable Use

All users are expected to:

- Use the internet primarily for educational purposes aligned with school goals.
- Access only age-appropriate and educational websites and digital resources.
- Respect copyright and intellectual property laws.
- Communicate respectfully and ethically in all digital interactions.



- Log in using only their assigned credentials and protect their login information.

4. Prohibited Activities

The following actions are strictly prohibited:

- Accessing or distributing inappropriate, violent, or offensive content.
- Engaging in cyberbullying, harassment, or any form of online misconduct.
- Downloading or installing unauthorized software or media.
- Attempting to bypass network filters or security settings.
- Using the internet for commercial or personal financial gain.
- Sharing personal information such as address, phone number, or passwords.
- Misusing social media platforms during school hours or on school premises.

5. Digital Citizenship

DIIS promotes responsible digital behavior:

- Be kind, respectful, and inclusive in all online communications.
- Think critically about the credibility and accuracy of online sources.
- Use digital tools to collaborate positively and productively.
- Report any suspicious or inappropriate online activity to a teacher or administrator immediately.



6. Monitoring and Privacy

- Internet usage on school networks and devices is monitored and logged.
- Users should have no expectation of complete privacy while using school technology.
- Breaches of this policy will be investigated and may result in disciplinary actions, including suspension of internet privileges.

7. Cybersecurity Measures

To maintain network security, the school:

- Implements firewalls, antivirus software, and web filtering systems.
- Regularly updates security protocols.
- Encourages users to report suspicious emails or security breaches.

8. Use of Personal Devices

- Students must obtain prior permission to use personal devices on campus.
- Devices must be connected to the school's secure network and comply with acceptable use standards.
- The school is not responsible for loss, theft, or damage of personal devices.

9. Parental Involvement

- Parents are encouraged to support responsible internet use at home.
- The school may conduct workshops or issue guidelines to help parents stay informed on online safety practices.



10. Consequences of Misuse

Violations of this policy may result in:

- Verbal or written warnings.
- Temporary or permanent loss of internet or device access.
- Parent conferences.
- Suspension or other disciplinary measures, depending on the severity.

Digital Conduct Policy for Parents and Students

1. Personal Responsibility in Online Spaces

2. Respecting Privacy and Confidentiality

Social media is not a private platform. Please refrain from discussing or disclosing confidential information, internal communications, or any specific details related to students, staff members, or school operations.

3. Use of School Identity

The use of Disha Indian International School's name, logo, or official imagery without prior authorization is not permitted. If you'd like to promote a school event or activity, kindly share posts directly from the school's official social media accounts.

4. Professional Boundaries Between Staff and Parents

Faculty and staff are not obligated to accept friend or follow requests from parents on social media. Please respect their privacy and boundaries. Discussions about sensitive matters concerning the school should not be conducted through social media platforms.



5. Responsible Engagement on Social Networking Platforms

5.1 Awareness of Public Exposure

Regardless of privacy settings, all online activity should be treated as publicly accessible. Platforms like Twitter and Instagram often lack robust privacy safeguards, and posts can be widely shared.

5.2 Reflecting School Values

We encourage the Disha Indian International School community to uphold integrity, kindness, and mutual respect in their online interactions. Given the school's diverse community, all online comments should be respectful, constructive, and free from offensive language. Refrain from spreading misinformation or making disparaging remarks about any individual or the school as a whole.

5.3 Avoiding Inappropriate Content

Content that promotes or references age-inappropriate behavior, or includes discriminatory language, profanity, or suggestive remarks, should not be posted or shared.

6. Digital Guidelines for Students

6.1 Compliance with Platform Age Rules

Students must adhere to the age restrictions set by social networking platforms. Parents are encouraged to monitor their child's online presence to ensure compliance.

6.2 Online Accountability

Students are expected to take ownership of their digital actions. All content posted, commented on, or shared is reflective of the student's personal voice, not that of Disha Indian International School.



6.3 Maintaining Privacy

2. **Respectful Conduct:** Parents are expected to communicate respectfully and responsibly. 4. **Privacy and Confidentiality:** The sharing of confidential or personal information about students, staff, or families is strictly discouraged. 6. **Relevance and Group Etiquette:** To avoid unnecessary clutter, responses to individual questions should be sent directly via private message where possible. The group should remain focused on class-related matters, school events, or useful community information.
